STATEMENT

[1] Following discussions between the parties we have approved amended directions for the filing and service of submissions. As a result of those amendments the hearing dates require alteration. The hearings on 4, 5, 6, 7 and 8 April 2005 are cancelled. The Commission will now sit in Melbourne on 11, 12, 13, 14 and 15 April 2005 with 18 April 2005 also available if required.

[2] In all other respects the arrangements set out in the statement we issued on 7 December 2004 are unaltered.

AMENDED DIRECTIONS

1. The ACTU, on behalf of the union applicants, and any party or intervener in support (other than those identified in paragraph 2) are to file and serve on all other parties and interveners by 18 February 2005:

(a) submissions in support of the applications;

(b) affidavits of any witness evidence in support of the applications.

2. The State and Territory Governments are to file and serve on all other parties and interveners by 25 February 2005:

(a) their submissions;

(b) affidavits of any witness evidence in support of the applications.

3. The submissions of all other parties together with affidavits of witness evidence, are to be filed and served on parties and interveners by 11 March 2005.

4. The ACTU and any party or intervener in support are to file and serve any reply on all other parties and interveners by 4 April 2005.

5. All other parties are to file and serve on the ACTU, interveners and each other any material in response to the ACTU's reply by 7 April 2005.

6. The ACTU may not file any material after 4 April 2005 unless by leave of the Commission, which leave shall not be granted unless:

(a) the material relates to economic data, academic studies or reports not available to the ACTU prior to that date; or

(b) there are special circumstances which warrant the filing of such material.

7. Subject to paragraph 9 no other party may file any material after 7 April 2005 unless by leave of the Commission, which leave shall not be granted unless:

(b) there are special circumstances which warrant the filing of such material.

8. There will be liberty to any party to apply.

9. Any party wishing to make a further submission after the Commonwealth Budget 2005-06 should do so in writing to be filed in the Registry and served on all other parties and interveners on or before 17 May 2005.
